**1.2.2.1** CLARIFICATION, in Servery 201A, there is an existing chalkboard along the south wall noted RR. This is to be reinstalled at item 33 located in the Hospitality Bistro 202, as noted on drawing A-04.

    - **1.2.4.1** CLARIFICATION, the food service contractor is not required to include a price for inspection of the existing equipment in their bid price.

#### ELECTRICAL

Item 1

- 1.0 Reference Specification Section 27 31 40
  - .1 In the "Scope" section, delete 1.3.1.2 (Connections for temporary staff trailer).
  - .2 Delete 2.1.25 (Temporary staff trailer connections) entirely.

#### Item 2

- 2.0 Reference Drawings E04, E-05 and Attached Sketch SKE-5
  - On drawing E-04 on the basement renovation plan at existing telecom closet 'G' located in Room 107A, provide new patch panel to suit existing wall bracket and coordinate with School Board for relocation of existing data switch to facilitate new patch panel. Observe labeling standards of horizontal data cabling per specifications. All data communications cabling from the ground floor Hospitality area is to terminate here. On drawing E-05 and sketch SKE-5, provide 1 – 53mm (2") riser conduit between ceiling space of Hospitality Room and ceiling space of lower level corridor over to existing cable management system and up corridor to Telecom Closet 'G' in Room 107A. This contractor to firestop the penetration at 2 hr rated floor/ceiling assembly. All telecom outlets in Hospitality renovation area shall have conduits run in ceiling space to the vicinity of the new riser conduit.
